

Free Parking at Toledo Express Airport Official Promotion Rules

1. Description of the Promotion: Travelers who fly internationally from Toledo Express Airport connecting through Charlotte Douglas International Airport (CLT) or Chicago O'Hare International Airport (ORD) are eligible for free parking at Toledo Express Airport for the duration of their trip.
2. All participants must be 18 or older and must cooperate with the Toledo-Lucas County Port Authority based on these Official Promotion Rules. No substitution or transfer of promotion is permitted. Only one vehicle refund allowed per person and only one refund per vehicle. Travelers are only eligible for free parking during the duration of their trip.
3. To participate in the promotion, travelers will pay for parking when exiting the lot at Toledo Express Airport and must then submit the following information to receive a full refund:
 - a. To redeem free parking, travelers must email their flight itinerary (boarding passes or copies of boarding passes will not be accepted) of their round-trip flight for each segment of the trip originating from Toledo Express Airport and landing at an international destination through Charlotte or Chicago, an original parking receipt with the full amount paid at Toledo Express Airport, their name, address, and phone number to parking@toledoport.org. The flight must depart from Toledo Express Airport and the final destination must be an international destination and must be a connecting flight through Charlotte or Chicago. Any flight itinerary that does not meet these requirements is not eligible for this Promotion. Travelers can also mail these items to One Maritime Plaza, Toledo, OH 43604.
4. Refunds for parking fees are limited to one per vehicle. Parking fees will normally be reimbursed by ParkSmart within 30 days of the email being received with all required information. Any traveler who fails to provide the required information will be ineligible to receive a refund. Multiple individuals who share a vehicle are prohibited from submitting more than one reimbursement request per vehicle.
5. This promotion will run from March 18, 2019 - December 31, 2019. Travelers will only be eligible to receive a reimbursement for travel dates between March 18, 2019 December 31, 2019, and must submit documentation for reimbursement no later than January 1, 2020. Any trip that extends beyond December 31, 2019 will only be eligible for reimbursement of parking fees applicable through December 31, 2019.
6. Parking fees related to flights to U.S. destinations through Charlotte or Chicago, or Charlotte or Chicago as the final destination are not eligible for reimbursement.
7. All participants must agree to these Official Promotion Rules in order to participate. Submitting a request for reimbursement for parking constitutes agreement to the Official Promotion Rules. Failure to comply with these Official Promotion Rules may result in disqualification from the Promotion.
8. This Promotion is governed by the laws of the State of Ohio and is subject to all federal, state, and local laws.
9. The Port Authority reserves the right at its sole discretion to cancel, terminate, modify, or suspend the Promotion for any reason in its discretion. In addition, any person who attempts to violate these Official Promotion Rules will be disqualified from this Promotion and ineligible to receive a refund in any amount.
10. By participating in this Promotion, the participant fully releases and discharges the Toledo-Lucas County Port Authority, Toledo Express Airport, the City of Toledo, and their respective directors, officers, and employees from and against any and all actions, charges, claims, losses, costs, damages, expenses (including attorneys' fees and expenses) and liabilities of any kind or character, whether known or unknown, in connection with, arising out of or in any way related to his/her participation in the Promotion.
