

Free Parking for International Travel at Eugene F. Kranz Toledo Express Airport

Official Promotion Rules

1. Description of the Promotion: Travelers who fly internationally from Eugene F. Kranz Toledo Express Airport (TOL) connecting through Chicago O'Hare International Airport (ORD) are eligible for up to \$120 in free parking at TOL for the duration of their international trip, between May 1, 2022 through August 31, 2022.
2. All participants must be 18 or older and must cooperate with the Toledo-Lucas County Port Authority based on these Official Promotion Rules. No substitution or transfer of promotion is permitted. Only one vehicle refund allowed per person and only one refund per vehicle. Travelers are only eligible for free parking. Travelers are only eligible for free parking during the time in which they are traveling, as indicated by the dates and times on flight itinerary.
3. To participate in the promotion, travelers will pay for parking when exiting the lot at Toledo Express Airport and must then submit the following information to receive a refund:
 - a. To redeem free parking, travelers must email their (1) flight itinerary (boarding passes or copies of boarding passes will not be accepted) of their round-trip flight for each segment of the trip originating from Eugene F. Kranz Toledo Express Airport and landing at an international destination through Chicago, (2) an original parking receipt with the full amount paid, and (3) their name, address, and phone number to parking@toledoport.org. In order to be eligible, the traveler's flight itinerary must evidence that the flight departed from TOL, that the traveler's final destination was an international destination, and that the traveler had a connecting flight through Chicago. Any flight itinerary that does not meet these requirements is not eligible for this Promotion. In lieu of emailing a refund request to parking@toledoport.org, travelers can also mail these items to Toledo-Lucas County Port Authority, One Maritime Plaza, Toledo, OH 43604, attn: Communications.
4. Refunds under this Promotion are limited to one refund per vehicle. Parking fees will normally be refunded by ParkSmart within 30 days of the email being received with all required information. Any traveler who fails to provide the required information will be ineligible to receive a refund. Ineligible travelers will not be notified upon being deemed ineligible. Multiple travelers who share a vehicle are prohibited from submitting more than one reimbursement request per vehicle.
5. This promotion will run from May 1, 2022, through August 31, 2022. Travelers will only be eligible to receive free parking for travel that occurs between May 1, 2022, and August 31, 2022, and all refund requests, including supporting documentation, must be received no later than September 30, 2022. Any international trip that commences prior to May 1, 2022 or extends beyond August 31, 2022, will only be eligible for reimbursement of parking fees applicable through August 31, 2022.
6. Parking fees related to flights to U.S. destinations through Chicago, or to Chicago as the final destination are not eligible for this promotion.
7. All participants must agree to these Official Promotion Rules in order to participate. Submitting a refund request constitutes agreement to the Official Promotion Rules. Failure to comply with these Official Promotion Rules may result in disqualification from the Promotion.
8. This Promotion is governed by the laws of the State of Ohio and is subject to all federal, state, and local laws.
9. The Port Authority reserves the right at its sole discretion to cancel, terminate, modify, or suspend this Promotion for any reason in its discretion. In addition, any person who attempts to violate these Official Promotion Rules will be disqualified from this Promotion and ineligible to receive a refund in any amount.

10. By participating in this Promotion, the participant fully releases and discharges the Toledo-Lucas County Port Authority, Eugene F. Kranz Toledo Express Airport, American Airlines, the City of Toledo, and their respective directors, officers, and employees from and against any and all actions, charges, claims, losses, costs, damages, expenses (including attorneys' fees and expenses) and liabilities of any kind or character, whether known or unknown, in connection with, arising out of or in any way related to his/her participation in the Promotion.
