

## **Harvest Fest Pumpkin Express Ticket Giveaway Sweepstake OFFICIAL RULES FOR ROUNDTRIP AIRLINE TICKETS**

1. Description of the Sweepstake: The Toledo-Lucas County Port Authority (the “Port Authority”) is giving away four (4) roundtrip airline tickets to the winner’s choice of Orlando Sanford, Florida; St. Pete-Clearwater, Florida; Fort Myers/Punta Gorda, Florida; or Phoenix, Arizona on Allegiant out of Eugene F. Kranz Toledo Express Airport (TOL) during Harvest Fest at the Toledo Zoo & Aquarium. Participants must post a photo of themselves or their family members on the Pumpkin Express to Facebook, Twitter, and/or Instagram with hashtag #TOLPumpkinExpress to be eligible for entry. This sweepstake will accept entries from October 1 to October 31, 2023. A winner will be determined in a raffle drawn by the Toledo-Lucas County Port Authority on October 31, 2023, at 4:00 p.m. and will be notified via email. Winner will have three (3) business days to claim prize before another winner is drawn.
2. The winner of the tickets must agree to cooperate with the Port Authority based on these Rules in order to successfully use the tickets. Must be 21 or older to win. Immediate family members of Port Authority and Toledo Zoo & Aquarium employees, are ineligible to enter. No substitution of the tickets is permitted. Air travel tickets are for air travel only. Prize does not include assigned seats, checked baggage, hotel, car rental, insurance, applicable taxes, travel documents, or any other expenses and incidentals not expressly included in the description and such items are the responsibility of the winner.
3. To enter, contestants must post a photo of themselves or their family members on the Pumpkin Express to Facebook, Twitter, and/or Instagram with hashtag #TOLPumpkinExpress. One entry per person, per social media platform. Must be 21 or older to enter.
4. All participants must agree to these Official Rules in order to enter this Sweepstake. Entering this Sweepstake constitutes agreement to the Official Rules. Failure to comply with these Official Rules may result in disqualification from the Sweepstake. Prize: One winner will receive four (4) roundtrip airline tickets to the winner's choice of Orlando Sanford, Florida; St. Pete-Clearwater, Florida; Fort Myers/Punta Gorda, Florida; or Phoenix, Arizona on Allegiant out of Eugene F. Kranz Toledo Express Airport (TOL). The winner is to choose three dates between the date they are notified of their prize and May 13, 2024, to fly. Preferred dates must be sent to [contactus@toledoport.org](mailto:contactus@toledoport.org) and booked by December 20, 2023. A 14-day advance booking is recommended. The dates will be booked by Port Authority staff based on availability. The winner will be required to sign legal documentation before the travel can be scheduled. The Port Authority retains the right in its sole discretion to make substitutions of equivalent kind or approximate value in the event of the unavailability of travel dates for any reason. The winner will be responsible for the payment of any taxes that apply to the tickets as well as any incidentals or expenses. There is no cash alternative and the tickets must be taken as offered. Furthermore, the Port Authority is not responsible for cancellations or delays in travel accommodations and has no obligation to reimburse, refund or otherwise substitute any tickets due to such cancellations or delays. Airline tickets are nontransferable and must be used by the winner of the prize. Total value of each tickets is not to exceed \$1,000. The winner will be issued a tax form 1099 for any prize that exceeds \$599 in value.
